Eligibility

To apply for free, you must meet all the following four criteria:

- 1. You attended a state school
- 2. You have been resident in the UK for the past three consecutive years
- 3. You are applying for the BA (Hons) in Acting
- 4. You are new to Higher Education (ie. new to university/degree level training)

In addition to the essential criteria listed above, applicants should also meet at least one of the following criteria (please tick):
